## Allister Pricks Whatever Conscience Remains on Principal Deputy Speaker



Jim Allister opposes the SF/DUP deal to elevate Francie Molloy

Jim Allister pricked the conscience of Assembly Members before the vote to make Francie Molloy Principal Deputy Speaker:

In a statement the North Antrim MLA said:-

“Once more in the face of provocation and orchestrated hostility, and a malevolent Parades Commission, the Ballymaconnolly parade has taken place with great discipline and decorum. I congratulate the organisers

TUV Councillor Roy Gillespie and Party Secretary Joel Johnston have met with residents from Cullybackey to discuss plans for a through road before a public meeting with DRD Minister Danny Kennedy. The TUV delegation listened to the concerns of the local residents regarding the volume of traffic that passes through the main street. Residents are campaigning for the Minister to provide the 4 million pounds necessary to build a through-road that would alleviate much of pressure caused by the 13,000 vehicles that daily pass through Cullybackey.

Jim Allister has expressed concern about the state of fishery stocks and the extent of pollution incidents affecting the River Maine system.

In a series of detailed Assembly questions Mr Allister has established that whereas there is yet no appropriate assessment tool to measure trout stocks, in regard to salmon in 2010 there was only 61% of the number of eggs required to sustain stocks at an

## **TUV Backs Cullybackey Residents**

Residents were assured of support from the TUV for their campaign and will meet party leader Jim Allister next month.

Commenting Mr Allister said,

“These worrying trends are related, I believe, to other information which I unearthed in other questions, namely the excessive number of pollution incidents and the introduction of a mere ‘on call’ bailiff service. “The River Maine system is a wonderful natural

asset enjoyed by many, not just fishermen. Yet, sadly, as a fishing facility it has been allowed to diminish, largely because of inadequate attention from DCAL, the bailiff system now in place and the failure to address the pollution incidents in a proportionate manner.

“I will continue to monitor the situation to see what improvements, if any, DCAL and the Environment Agency bring.”

## Electricity Prices Inflated by North - South Links

Jim Allister MLA has spoken out against the news that hard pressed consumers will be hit with a massive 20% hike in the price of electricity later this year which follows a huge hike in 2008.

Commenting on the hike Jim Allister argued:

“It is important to remember a point which is ignored by many of those who will feign sympathy with the public when it comes to this issue. One of the reasons for the runaway price of electricity in Northern

Ireland was the creation of the single electricity market on the island of Ireland, which Nigel Dodds championed when DETI Minister, followed, most significantly, by the sale of NIE to the Republic's semi-state ESB. I warned at the time Northern Ireland consumers would be bled dry the deeper ESB and the Republic got into decline.

“Prior to the Assembly recess I asked the DETI Minister Arlene Foster a series of questions relating to the price of

electricity in the Province. I established that customers in Northern Ireland pay more than any other part of the United Kingdom and that prior to the establishment of the North/South arrangements NI figures were converging with GB prices but are now diverging again as the gap with the ROI closes.

Additionally, I pressed her on what plans she had to oversee a reduction in the cost of electricity.

## Closure of A&E Departments

TUV responded to a public meeting discussing the potential closure of Belfast City A&E department. Our concerns included:

- \* The absence of any explanation for closing the more utilised City hospital over the Mater Hospital A & E.
- \* The evident strategy to induce closure by 'temporary' measure. We believe the public deserve clarity therefore the Health Minister must come clean as to whether his real intention is to permanently close the City's department.
- \* The lack of a clear strategy

or consideration of the capacity of the Royal and Mater hospitals to treat the patients that use the Belfast City Hospital

\* The result of all A & E departments being located in the West and North Belfast constituencies, with disadvantage to unionist areas.

\* How it comes about that when Michael McGimpsey was talking about severe cuts resulting from the DUP/Sinn Fein budget, the DUP was proclaiming there was ample funding, yet now is moving to remove this vital service from South Belfast

Commenting on the public meeting TUV stated:

“The TUV welcomes the public meeting as it affords members of the public the opportunity to demand answers from their local representatives. The devolved administration in Northern Ireland was hailed as a great achievement by the architects of the Belfast Agreement because it was said to provide caring, responsive government and an opportunity for the people to hold their politician's to account. The response to public opposition to closure of the City's A & E will test that pledge.

## Where now the promise of caring, sensitive government under devolution?

Jim Allister has labelled the behaviour of the Department of Justice over the Police Reserve Gratuity as 'a disgrace'.

Commenting on the issue Jim Allister stated:

“David Ford's intransigent holding to an arbitrary, ill-publicised deadline, which is adding immense hardship to one of the most deserving sections of society, throws into sharp relief all the heady promises about the value of devolution. Weren't we repeatedly told how local

politicians in charge would bring caring, sensitive government? Direct rule at its worst wouldn't have taken as cruel a stance as that which Ford is clinging to.

“For someone who preaches flexibility in politics he is being remarkably intransigent.

“It is strange how David Ford found breaches of decommissioning deadlines by the Provos and others acceptable, but holds those they were trying to murder to the letter of his artificial deadline when it comes to a

gratuity recognising their valiant service. His stance is an utter disgrace.

“In addition to continuing to lobby for those ex Reservists who have approached me I will be urging them to refer the matter to the Ombudsman as maladministration because of the inadequacy of the publication process, the lack of serious effort to contact those who had served - though their contact details were obtainable - and the absence of an accessible and serious appeal process.”

## TUV leader Presses Parades Commission over Blasphemous Placard in "Gay Pride"

Jim Allister MLA braved a media storm to defend the rights of Christians following an offensive Gay Pride parade.

Jim Allister explained that:

"Following the displaying of a highly offensive placard at Belfast's "gay pride" parade I wrote to both the PSNI and the Parades Commission expressing my concern.

"A poster was carried during the annual parade bearing the words, "Jesus had two Dads and he turned out just fine".

"Such sentiments would not be permitted if Mohammed had been the object of the

marcher's mockery. Why should Christianity be treated any differently?

"This year – as has been the case previously – the "Pride" parade has been anything other than the family friendly event which the organisers attempt to portray it as. Christians peacefully demonstrating at the event were subjected to a torrent of foulmouthed abuse and obscene gestures.

"It is high time that the organisers of Belfast Pride were held accountable for the actions of those who take part in the parade."

## Allister Exposes Translink Double Standards

After meeting with Translink and waiting more than a month for a reply regarding the company prohibiting the wearing of wristbands commemorating local men serving in Afghanistan. TUV has received a reply.

commenting on the reply Jim Allister MLA stated:

"Translink's reply is wholly unsatisfactory as it provides no explanation as to how and why the discreet wearing of an wristband supporting our troops could be offensive and while they refer to 'advice' from the Equality Commission they do not say what that advice was.

"However, the most intriguing



thing about Translink's answer is the company's solemn commitments to 'equality' and 'neutrality'. In light of same I have invited Translink to explain to me why they have tolerated for years a shrine to republican terrorism on the railway embankment at Newry.

## Moyle-Gaza Saga

The following Statement was presented to Moyle Council Meeting on Monday 22 August 2011 by Cllr Sharon McKillop.



"I propose that Moyle Council revoke the decision to support the twinning project with Gaza.

I fear that the implications of the twinning project between Moyle and Gaza Councils will have a negative impact on Moyle Council.

While there are further political arguments against the twinning project I would prefer that the debate focuses on what is best for Moyle Council and for the people of this borough.

I will succinctly outline why

Councillors should choose the sensible option of revoking the decision of the previous Council to undertake a twinning project.

1. Community Relations: The previous Council decided to proceed with the twinning project despite all elected unionist representatives rejecting the proposal. Therefore it is evident that Unionists feel deeply uncomfortable about the twinning project. Cllr McShane has previously claimed that the decision to twin Moyle and Gaza Councils was non-political and that it had support from across the community indeed he further claimed that it was a collective decision by Moyle Council. However the decision to twin Moyle and Gaza councils was never supported by Unionist representatives and therefore never commanded community support. I would

therefore ask council representatives to consider how the twinning project could have a positive impact on local relations when a significant minority remain hostile to it.

2. Tourism: Gaza Council is controlled by the Hamas group. Hamas seized political power in 2007 and this year refused to hold legitimate municipal elections. Furthermore Hamas remains classified as a terrorist organisation within both Europe and the US. Not only do these honest facts provide a basis for questioning the legitimacy of the Gaza Council it also means that visitors from the US and elsewhere in Europe may chose not to visit the Moyle area or at best be uncomfortable about doing so because their governments view Hamas as a terrorist organisation.

3. Administration/Costs to Taxpayer: The costs to the taxpayer remain unknown.

What will the administration costs associated with the project amount to? Will Moyle Council be funding the visit of Gaza representatives? How much will the 'urban planning' amount to and most importantly as already highlighted how much will it cost in lost revenue from tourism? With these economic questions unanswered how can councillors continue to support the twinning experiment?

Given these arguments that I have clearly presented I would close by asking my colleagues if they really want to twin our Council with somewhere that would divide the community and hinder economic progress.

This move is both backward and divisive – if Moyle Council want to 'move forward' then they should revoke the twinning motion."
