Allister Makes the Case for A26

One of the cardinal issues that has afflicted the North Antrim constituency is the state of the A26. The road is one of the main arteries in Northern Ireland, has one of the highest daily vehicle usage figures, and has a tragic death rate. So, it is necessary that the inadequacy of the road is addressed.

The issue is, in effect, about developing the economy of North Antrim, because there is an inextricable link between good road access and economic development. It is no coincidence that Ballymena, to which we have good road links, has seen industrial growth. Speaking in the Assembly Jim Allister argued that,

"In the provision of nursery places, we have got out of kilter in the prioritising of social need. Secret Society?

TUV Leader Jim Allister MLA has established, through questions to the Justice Minister, that since 2007 four "super injunctions" have been issued by the High Court in Belfast.

Commenting on the revelation Jim Allister said;

"The mystery and secrecy surrounding injunctive relief is generally not healthy, nor does it sit comfortably with the transparency expectations of a modern society. Thus, establishing that there have been four 'super injunctions' in Northern Ireland contributes in a small way to redressing the balance of secrecy.

The growth of 'super injunctions' is a product of the courts being persuaded to prioritise privacy rights over freedom of expression and press rights within the Human Rights Act. I am far from convinced that this balance is weighted in the right direction, particularly where it is a facility which in practical terms is only likely to be available to those who can afford it.

n Northern Ireland there has not been the level of debate necessary in a democracy about these issues and, therefore, I trust the release of this limited information may stimulate some necessary debate."

Mystery of the Missing Millions

In these hard economic times when ordinary families are facing serious financial pressures it is more important than ever that they know the powers that be are being prudent when it comes to tax payer's money.

However Jim Allister has been dismayed by the amount of money spent on consultants at the Assembly.

The Office of the Joint First Ministers has spent a shocking $\pounds 16,036,000$ on consultants over the past four years.

The Department of Education has spent in excess of £2,000000 of tax payer's money on external consultants. Despite this huge outlay the department has continually failed to do anything to solve the selection crisis which has caused so much heartache across Northern Ireland.

Enraged by the huge expenditure on consultants and administration, Jim Allister raised the roll-out of Axis 3 of the Rural Development Programme and, in particular, the amount of money spent on administration, rather than on delivery during the first question to the Minister for Agriculture.

However the Minister was unable to give the breakdown

between bureaucracy costs and money actually paid out.

Jim Allister will continue to scrutinise how much departments are wasting.

Commenting on the consultant Bill accumulated by OFMDFM and the Education department Jim Allister stated:

"I have already asked a number of other government departments how much they have spent on external consultants since the restoration of devolution and will be challenging all of them in due course to reveal how much public money has been used in such a fashion."

394 abortions in NI since 2006, WHY?

Jim Allister has discovered that there were 394 abortions performed in Northern Ireland's hospitals since 2006. However while the Department of Health holds statistics on the number of abortions, information on the reason for abortion is not collected centrally.

Jim Allister will be asking Minister Poots if he will review the current practice of not recording and collating the reason for each abortion and issue guidance that such should be done.

It is an ideal time to address the issue as the DHSSPS's Guidance on the Termination of Pregnancy is currently at consultation stage.

Commenting on his findings Jim Allister stated, "Given that abortion in Northern Ireland is only permissible in cases where the life of the mother is in danger, I am surprised that this data is not already recorded. Given the sensitivity of the matter and the undeniable public interest in abortion in Northern Ireland I believe that the reason for each abortion should be recorded in order for there to be maximum public confidence that the law is being complied with."



In June DUP Speaker William Hay rejected Jim Allister's move to rule that all MLA's refer only to Northern Ireland when in the House

Kingsmill Report Welcomed

Jim Allister argued that;

"The Kingsmill massacre was one of the most horrific incidents in the Troubles. Few incidents illustrated the sectarian nature of the IRA's murder campaign as

In pointing the figure of blame at the IRA the report simply confirms what everyone already knew but it is welcome in that it vindicates what the families have been saying for so many years.

Sadly the full truth of what happened that terrible day is still hidden. Yes it was the IRA which carried out the murders but who within that wicked organisation? No one has ever been brought to justice.

Worse still those who continue to justify the IRA's bloody sectarian campaign sit at the heart of our government."



TUV Councillor Boyd Douglas launched a protest in June following the appointment of Sean McGlinchey to the position of Mayor in Limavady. McGlinchey planted an IRA bomb in Coleraine which killed six people in 1973.

Cllr Douglas brought two meetings to a standstill by

producing a Union Jack flag in protest against McGlinchey's appointment. His actions caused a media furore and acted to ensure the victims of McGlinchey's heinous crime were not forgotten.

Cllr Douglas has been inundated with messages of support for his protest.

Commenting Cllr Douglas stated:

"Not everyone may agree with the method of my protest, but they thanked me for standing up and expressing the anger and hurt that is felt."

Allister Leads the Calls to Resolve Milk Cup Funding Fiasco

Jim Allister has taken the opportunity to question Minister Foster about the funding crisis which surrounds the Milk Cup.

The Milk Cup's application to the Northern Ireland Tourist Board was rejected because it "failed to meet the minimum assessment score required to merit an award" and after their appeal the organisers were informed that, "The panel felt there was not enough information detailed in the application form to merit an award".

Commenting on the funding fiasco Jim Allister stated;

"The Milk Cup has been held annually for the past 28 years yet in the NITB's "Event Viability and Management Experience" category the Milk Cup scored 29 out of 65. That fact alone is sufficient to demonstrate just how preposterous the Tourist Board's decision is.

But it gets worse. The Milk Cup scored 10 out of a possible 20 when it came to "Brand Northern Ireland"! Personally I would be hard pressed to think of another event which does more to promote Northern Ireland as a brand. Here is an event which has been held in our Province annually for the best part of three decades. It is a major youth sporting event which generates considerable interest overseas. Not only does the event bring young sports people to Northern Ireland and but it is also broadcast on major TV stations.

Manchester United TV (MUTV) for example covers the tournament on a daily basis and at the end, a one hour documentary is shown on their satellite station which, I understand, is the football club channel with the largest number of subscribers worldwide.

During questions to the Minister for Enterprise, Trade and Investment, I pressed Mrs Foster on the issue as she has ministerial responsibility for tourism. It is regrettable that the Minister has not yet pulled the NITB into line."

Jim Allister has pledged to continue the funding fight on behalf of the Milk Cup and has tabled an adjournment debate on the matter.
